All are requested to bring the practical records with Identity Card with hall ticket on said date for evaluation cum viva voce at RC.

All eligible learners are also requested to bring a report for the seminar course MVPS-01 for evaluation/viva voce on 14.04.2025 (10.00AM)

Learners who have taken fresh admission from Jan 2023 admission session onwards will have to pay the practical examination fees as per the IGNOU notification. If the desired practical courses are not showing in his/her hall ticket (for TEE Dec 2024) then he/she has not paid the required fees. Learners who have not paid practical exam fees for TEE Dec 2024 should submit a **Demand Draft (DD) drawn in favour of IGNOU and payable at Bhubaneswar on the scheduled date.**

Without payment of practical fees, the awards will not be updated in the Grade card.
