Indira Gandhi National Open University (IGNOU) has been established by the Government of India by an Act of parliament in 1985 (Act No 501985) with the objective of enhancing access to quality higher education through distance mode. The university has been mandated to:

Provide access to higher education to all segments of the society :

Offer high-quality, innovative and need-based programmes at different levels, to all those who require them:

Reach out to the disadvantaged by offering programmes in all parts of the country at affordable costs.

Open and Distance Learning (ODL) system is a system where in teachers and learners need not necessarily be present either at same place or same time and is flexible in regard to modalities and timing of teaching and learning as also the admission criteria without compromising necessary quality considerations. ODL system of the country consists of Indira Gandhi National Open University (IGNOU) State Open Universities (SOUs), Institutions and Universities offering education and includes Correspondence Course Institutes (CCIs) in conventional dual mode Universities. This is becoming more and more significant for continuing education, skill updation of in service personnel and for quality education of relevance to learners located at educationally disadvantageous locations.

With the dissolution of the Distance Education Council of the IGNOU, the regulatory powers on ODL are currently vested with the University Grants Commission (UGC).

IGNOU offers about 230 different programmes of Ph.D., M.Phil, Masters, undergraduate, Post graduate Diploma, Diploma and Certificate programmes round the year i.e January and July session through Offline and Online.



IGNOU has a network of 67 Regional and more than 3000 Study Centres across the country. Academic supports are being provided to the learners at the Study Centres. Admission Cycles are open round the year for two cycles January and July each year. The filled-in admissions forms along with necessary documents and requisite fee are submitted at the Regional Centre Bhubaneswar.
